## LEGAL NOTICE OF PUBLIC HEARING PROPOSED ZONING BYLAW AMENDMENTS

Notice is hereby given that, under M.G.L. Chapter 40A Section 5, the Carlisle Planning Board will hold a Public Hearing on Monday, September 29, 2025 at 7:00 PM, in the Clark Room at Carlisle **Town Hall, 66 Westford Street**, and **remotely over Zoom**, to consider the following proposed Zoning Bylaw Amendments in advance of the November 2, 2025 Special Town Meeting: add new section, Section 5.13 MBTA Communities Multi-Family Overlay District, to provide for any of the following options, or a combination of the following options, which would allow Multi-family housing as of right via Site Plan Review by the Planning Board at a density of 15 units per acre pursuant to M.G.L. Ch. 40A s. 3A and 760 CMR 72.00: (1) One Site - Minimum Land Area, to allow 95 units on one site with a land area close to 6.33 acres; (2) One Site – Larger Site or Area, to allow 95 units within a 6.33-acre 'Development Area' of a larger site, or a variation of this split across two adjacent sites; (3) Cluster Development, to allow 95 units dispersed across multiple sites of varying sizes, each site zoned for 10-30 units clustered on a 1- to 2-acre 'Development Area' of the site, and to allow for mixed-use on sites with existing commercial, institutional, and house of worship uses; (4) Scattered Sites – Anchor Area, to allow 95-96 units dispersed across 1 large anchor area and multiple clusters of approximately 2-acre sites, each site zoned for 3 units on an 8,712 square foot 'Development Area' of the site; (5) Scattered Sites - Anchor Cluster, to allow 96 units dispersed across an anchor cluster of 16 approximately 2-acre sites and multiple smaller clusters of approximately 2-acre sites, each site zoned for 3 units on an 8,712 square foot 'Development Area' of the site; or (6) a combination of Cluster Development zoning and Scattered Sites zoning, allowing 95 units dispersed across multiple sites of varying sizes, each site zoned for a certain number of units within a specified 'Development Area' of the site, and to allow for mixed-use on sites with existing commercial, institutional, and house of worship uses. In addition, the language in Section 2 will be amended to list the new overlay district and to update the map reference to reflect the revision date of the new zoning map.
